



# **THE CORPORATION OF THE CITY OF PORT COQUITLAM**

## **BYLAW NO. 3540**

*A Bylaw to Establish Fees and Charges for City Services and information.*

---

*Whereas Section 194 of the Community Charter, S.B.C., 2003, c.26, Council may, by bylaw, impose fees and charges payable in respect of any service it considers necessary or desirable;*

*And whereas Council deems it necessary and desirable to exercise the authority provided by the Local Government Act to cover costs or providing various services and information.*

*Now therefore the Council of the Corporation of the City of Port Coquitlam, in open meeting assembled, enacts as follows:*

**1. Citation**

This Bylaw is cited as “Fees and Charges Bylaw, 2006, No. 3540”.

**2.** The City of Port Coquitlam hereby imposes fees for the provision of services and information as specified in Schedules attached to this Bylaw.

**3.** This Bylaw shall come into effect on the date of its final adoption.

**4.** Whereas this Bylaw sets out fees and charges with respect to other City of Port Coquitlam bylaws and other such bylaws contain similar fees and charges, this Bylaw is deemed to prevail.

**5. Severability**

If any part, section, sub-section, clause, or sub-clause of this Bylaw is, for any reason, held to be invalid by the decision of a Court of competent jurisdiction, such decision does not affect the validity of the remaining portions of this Bylaw.

**6. Repeal**

That “Fee Setting Bylaw, 1996, No. 3018” be repealed and replaced by this Bylaw.

1. Fees and Charges do not include applicable taxes.
2. The standard fees are applicable for residential service connections that require an excavation depth of no greater than 1.8 meters and the utility main is located within 12 meters of the property being serviced. Service connections that do not meet the noted criteria will be quoted on a fixed cost basis.
3. Water, sanitary & storm sewer service connections located on Prairie Avenue, Pitt River Road, Shaughnessy Street, Kingsway Avenue and Cedar Drive will be quoted on a fixed cost basis.
4. The depth of the excavation must be no greater than 1.8 meters and the main to be tied in must be closer than 6.0 meters to the City water main. The contractor is to supply all required materials for the tie-in.
5. All other engineering works and services not identified in the Schedule B – Fees and Charges will be carried out on a quoted fixed cost basis.

**REQUESTS FOR WAIVING OF FEES**

Eligibility Criteria For Waiver Of Rental Fees:

- i) Waiver of fees will only be received by recognized non-profit Port Coquitlam groups for organizations whose memberships consist of a majority of Port Coquitlam residents.
  
- ii) Council via the Parks and Recreation Committee will review all applications for eligibility and that meet the criteria in the Parks and Recreation Fees and Charges Policy.

**1.1 MAJOR EVENTS ASSISTANCE PROGRAM**

This program is available to non-profit service groups, cultural, recreational and sport organizations to offset the facility rental costs of hosting a major regional, provincial, national or international event in a City of Port Coquitlam facility.

An organization must be a non-profit society to be eligible for assistance.
