

## 2026 Financial Assistance for Recreation - Process

**The following THREE documents are mandatory to process your application:**

1. Application Form (Pg 2)
2. Verification of financial circumstances (Pg 3)  
 'Proof of Income Statement' from CRA (Canada Revenue Agency)  
 or  
 A Community Partner Organization Reference Form
3. Proof of Port Coquitlam Residency (Pg 4)

<b>Step 1</b>	Gather all three documents: <ul style="list-style-type: none"> <li><input type="checkbox"/> Application Form</li> <li><input type="checkbox"/> CRA 'Proof of Income Statement' or a Community Partner Organization Reference Form</li> <li><input type="checkbox"/> Proof of Port Coquitlam Residency</li> </ul>

<b>Step 3</b>	The application will be reviewed and the applicant will be contacted within 10-14 business days.
<b>Step 4</b>	Approved applicants will receive a One City Membership Pass.
<b>Step 5</b>	In addition, approved applicants can request the scholarship/subsidy for eligible registered programs. This option provides \$200/year for each approved adult and \$500/year for each approved child/youth (0-18yrs). When using the scholarship/subsidy money, a 75% discount is applied to the registered program fee. The applicant will pay the remaining 25% of the program fee. The scholarship expires December 31st of the approved calendar year.
<b>Step 6</b>	You must reapply for financial assistance each calendar year.

## Verification of financial circumstances

### Option A: CRA 'Proof of Income Statement'

Check the Low Income Cut offs (LICO) table below to determine if you qualify. To be eligible, your total income before tax (gross income) must fall within the 2024 LICO table provided by Statistics Canada.

If you do qualify, please follow the steps below to get your 'Proof of Income Statement' from the CRA:

- (a) Online:** Get a Proof of Income Statement from the Canada Revenue Services Agency website in 'My Account'. Go to 'Tax Returns' tab, then 'Proof of Income Statement' on the right-hand side.
- (b) Order through MyCRA web app**
- (c) By mail:** Call 1800-959-8281 *This method may take up to 10 days to receive by mail*
  - Automated phone line is always open and a statement will be mailed. You will need to verify your identity when you call. Visit [Get a proof of income statement - Canada.ca](https://www.canada.ca/en/revenue-agency/services/tax/individuals/topics/about-income-statements/obtaining-income-statements.html) to find out what you will need to verify your identity with CRA.

From January – end of May 2026, individuals can submit 2024 Proof of Income Statement. From June – December 2026, individuals will need to submit 2025 Proof of Income Statement.

**\*Notice of assessment (NOA), T1 General or T4 statement and other documents CANNOT be used to replace the Proof of Income Statement.**

### Option B: Community Partner Organization Reference Form

If you do not have a Proof of Income statement or you are new to the country, please connect with one of our Community Partners to complete the Community Partner Organization Reference Form. ## Proof of Port Coquitlam Residency

We require a bill within the past 90 days that shows your name and Port Coquitlam address to verify your proof of Port Coquitlam residency.

Examples include:

- Home utility bill (cable, gas, hydro, internet, landline)
- Car insurance

Please note: We do not accept Tenancy Agreements as proof of residency.
