# **Notice of Public Hearing**

Zoning Amendment Bylaw No. 4416 - 2111 Hawthorne Avenue

Notice (s. 466 of the *Local Government Act*) is given that the City of Port Coquitlam will be holding a Public Hearing on **Wednesday, November 12, 2025,** at **5:00 p.m.** in the **Council Chambers at Port Coquitlam City Hall** (2580 Shaughnessy Street) to receive input from all persons and interested parties who wish to address Council regarding the proposed bylaw.

#### **Purpose of the Proposed Bylaw**

The intent of **Bylaw No. 4416**, is to amend Zoning Bylaw, 2008, No. 3630, to rezone the subject **property** as outlined in black on the map below, **from P2 (Institutional) to CD (Comprehensive Development Zone).** 



If approved, the application will allow for additional density, lot coverage and building height in order to facilitate a phased expansion of the Hawthorne Seniors Care Community, increasing their capacity for long-term care and adult day care programming.
