

## Notice of Public Hearing

### Zoning Amendment Bylaw No. 4452

Notice (s. 466 of the *Local Government Act*) is given the City of Port Coquitlam will be holding a Public Hearing on **Tuesday, July 14, 2026**, at **5:00 p.m.** in the **Council Chambers at Port Coquitlam City Hall** (2580 Shaughnessy Street) to receive input from all persons and interested parties who wish to address Council regarding the proposed bylaw.

### Purpose of the Proposed Bylaw

The intent of **Bylaw No. 4452**, is to amend Zoning Bylaw, 2008, No. 3630, to add a new Residential Townhouse 4 zone and permit townhouses as a conditional use in the RS zones, remove density bonus provisions from the RA1 zone and increase permitted density and height in the zone, and add density provisions to the Comprehensive Development 31 zone.

The Council meeting is open to the public and anyone wishing to attend may do so in person by attending Council Chambers. The meeting will also be broadcast live on the City's website and can be viewed by going to [portcoquitlam.ca/council](https://portcoquitlam.ca/council).
